TERMS AND CONDITIONS FOR THE INSTALLATION MAINTENANCE
AND OPERATION OF PAY PHONES, CCB PUBLIC TELEPHONE

1. Shri./Smt. _____ (Name of the applicants sanctioned) _____ (herein after called the license) will install and operate local public telephone at _____ (Name of place / City) _____ (allocation to be indicated by the license).
2. The licensee will be provided a direct exchange line with public telephone from CCB group (for local pay phone) for which no rent or installation charges will be levied.
3. Normal maintenance, repair and servicing facilities to the direct exchange lines provided to other subscribers will be extended by the Department of Telecom to the license. The licensee will follow the normal reporting procedure.
4. The licensee will be permitted to charge Rs.1.20 per call unit from the public for call made from the local PT. The licensee's commission will be 40 paise for local call unit.
5. The duration of the local call is 45 seconds as of now and 60 seconds from 16th March and no group dialing calls are allowed from the CCB PCO.
6. The licensee will have to pay the BSNL for minimum guaranteed amount of Rs.100/- per month in case of rural and Rs.300/- per month in case of less than 30,000 lines capacity and Rs.500/- in case of more than 30,000 lines capacity.
- 7. For Physically Handicapped persons security deposit is NIL.**
8. The licensee will procure, install, maintain and operate at his own cost the local PT at the agreed location. The licensee shall be responsible for the payment of Departmental bill / dues as per frequency responsible for the payment of bills will be made by the due date and local PT will be liable to be disconnected straightforth, for non payment.
9. The Licensee will make payments as per the metered calls recorded in the exchange.
10. The Licensee shall collect from the callers the prescribed charges for the calls at the Rates prescribed from time to time by the BSNL. He also take adequate step to see that the local PTs are not

misused and rate is higher than those prescribed by the Department are not charged. The BSNL will have full liberty in revising / modifying the rates of commission payable to licensee from time to time, charges leviable, rates of minimum quarter, security deposit and so on.

11. The Licensee will fully co-operate with BSNL to investigate any complaint from the public.
12. The Department will have the right to inspect so as to ensure that the local PTs are working as per the prescribed conditions of the Licensee as also regarding the rates being charged from the public.
13. The licensee will not be entitled to any rebate on account of wrong calls or alleged excess metering. No free call will be permitted.
14. All essential service numbers will be permitted free of charge by the Licensee.
15. No operator-assisted trunk calls will be permitted on these pay phones.
16. The Licensee shall organize and arrange for adequate number of coins/tokens for various denominations for the local PT users.
17. Local PT shall be kept open for the prescribed period of at least 12 hrs. Working from 8.00 AM to 8.00 PM.
18. The location of these public telephones can be changed by the Licensee in consultation with BSNL.
19. The licensee shall also have the right to replace the payphone with advanced, improved and modified versions as and when they may be introduced after due approval from BSNL.
20. The licensee shall be free to advertise the existence of the local PT.
21. The licensee can terminate this arrangement by giving notice of one month to BSNL. The BSNL will have the right to terminate the license in the event of breach of any of the provisions in the license by giving one month notice to the licensee. Notice shall be deemed to have been duly given if event to the premises of the licensee by registered post.
22. All the operations of the Licensee or his employees with respect to the provisions, maintenance and operation of pay phones will be

subject to the provisions of the Indian telegraphs Act and BSNL Rules.

23. Any dispute arising regarding the provisions of the Licence shall be settled through arbitrations as prayed under Section 7(b) of Indian Telegraph Act.
24. The Licensee shall not divulge or make known to any persons other than the Government, any of the matters relating to the business of the callers, which may come to the Licensee's knowledge.
25. The Licensee will have to abide by the current policy of the BSNL as revised / modified from time to time in respect of all the matters including the amount of security deposit, minimum guarantee amount, call charges to be levied, duration of the call, commission payable to the PT operator from time to time etc.
26. CCB PCO (Approved) instrument is to be fixed where easily accessible to the public.
27. The licensee of the Public Telephone booth should adhere to the following instructions:-
 1. The Licensee should prominently display the sign boards namely:
NO SERVICE CHARGE / BOOTH CHARGE FOR LOCAL CALLS.

No. Conference calls / any attachments like telephone instruments etc. are allowed.
Displaying of local call charges per call unit Rs.1.20/- only.
Public Telephone working Time from 8.00 AM to 8.00 PM (12 Hrs) Sign board
